## Davis Cup Drama: Haas Steps Aside, Aztec Waske Wins

Aztec Alex Waske was the hero of Germany's 4-1 defeat of Thailand in the World Group Davis Cup match in September.

First, the Frankfurt native, an All American at San Diego State (1998-2000), anchored a stunning doubles victory with Michael Kohlmann over Sanchai and Sonchat Ratiwatana of Thailand, 6-1, 6-2, 6-0.

Then, the team's top singles player, Tommy Haas, who had lost his first match, surprised Coach Patrick Kuhnen: "Alex has a chance of winning the next singles point. Let him play."

With Coach Kuhnen's approval, Waske took the court against Thailand's Paradorn Srichapan, who ranked 9th in the world in 2003. After taking a 6-4, 7-5 lead, Waske began to falter in a tiebreaker.

"Then he remembered our serving drills," said John Nelson, who coached Waske at SDSU and spoke later with Larry Willens, an Aztec coach who flew to Dusseldorf to assist Waske. "The drills pulled him through," said Nelson.

Waske won the final set, 7-6 (14-12), clinching the match

### Larry Belinsky Hits a Winner

A San Diego State tennis alumnus is the guiding force behind the establishment of a San Diego Tennis Hall of Fame.

Larry Belinsky, a businessman and top national senior player who lettered at San Diego State in 1973-76, conceived the idea of honoring San Diego's tennis history and lobbied tennis patrons and leaders to establish criteria and select the first ten inductees.

At a ceremony in August at Morley Field, Belinsky presided from the wings as inductees and their representatives were introduced and honored. A crowd of about 200 persons attended. Belinsky organized a dinner committee whose members arranged a catered meal for players, guests, and spectators.

The first inductees: Maureen Connolly Brinker, Michael Chang, Karen Hantze Susman, Dodo Cheney, Jean Doyle Garrett, Ben Press, Wilbur Folsom, Fred Kinne, William S. Kellogg, and Bill Bond.

### Requiem for an Aztec

Carmack Allgood Berryman, an Aztec tennis player (1935-38) who became the head teaching pro at the Hotel del Coronado (1950-1961) and remained a lifelong supporter of San Diego State tennis, has passed away.

One of Berryman's many appearances at Aztec matches came in February after he was a guest of honor at the dedication of the new Aztec Tennis Center. The next day, he sat on the sidelines wearing a woolen cap and a worried expression until the SDSU men scored the final winning points against Cal Poly.

In 2001, Berryman, then 87 years old, told ATR: "I majored in physical education

San Diego State men and women fought their way to the late rounds of four major American college tennis tournaments in the fall season and won championships in three important regional competitions.

At the national level, Aztecs

Markus Dickhardt and Chris Groh, both of Germany, reached the semifinals of the All-American tournament in Tulsa, OK, in October, and the quarterfinals of the ITA National Indoor Tournament in Columbus, OH, in November.

In regional competition, unseeded Aztec Holly Bagshaw of England won three matches to reach the quarterfinals of the Wilson/ITA Regional Championships in San Diego in October.

Aztec Achim Ceban of Russia won the University of New Mexico Balloon Fiesta Classic A Flight in October, defeating top seeded Lobo Graeme Kassautzki of Canada, 6-2, 6-4, in the finals and second seeded Peter Zimmer of Arizona, 3-6, 6-4, 6-0, in the semifinals.

Aztec Michael Beron of San Diego won the Balloon Fiesta B Flight in Albuquerque, defeat-

and social studies then took a teaching credential and masters' at Whittier College. I taught high school for many years and coached tennis at Lincoln High and Cal Western (now USIU)."

At the Hotel del Coronado Berryman taught many Hollywood actors, including Andy Rooney, George Murphy, Joe E. Brown, and Van Johnson, according to Ben Press, who has written a memoir of the hotel's tennis history.

## Requiem: Aztec Carmack Berryman

Despite the luminaries who visited the hotel, Berryman never seemed to lose sight of Aztec tennis.

He attended matches of both the men's and women's teams, telling friends that Aztec women's coach Peter Mattera, now in his 25th year with the SDSU program and 14th year as head coach, "was a little boy

when I played his father at the Hotel Del."

Author Press, head pro at the hotel for 28 years, wrote that Berryman once played a doubles exhibition with actor Rooney against Murphy (later a U.S. Senator), and tennis pro Pat O'Hara.

After splitting sets, Rooney and Berryman trailed 4-2 in a final set. Sud-

denly they stopped for a court-side conversation. What did they discuss?

Berryman confided later that Rooney had spotted two attractive women in the crowd and wanted Berryman to join him in asking them to dinner after the match. A married man and a gentleman, Berryman politely declined the invitation, then turned back to the match and, with Rooney's help, won it.

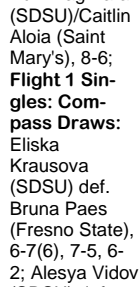
